The ageing population:

- 16m >65 by 2032 (48.7% rise) = 23.5% population
- >85 to double in next 20yrs
- 20% current population can expect to reach 100yrs
- 36% >65 live alone





- Latest figures from the Alzheimer's Society show that in England, 714,000 people are living with dementia.
- The vast majority (almost 95%) of those living with dementia are over the age of 65. There are, however, 42,325 people under 65 who have dementia
- 50% of people with Dementia will be undiagnosed
- Dementia is the most feared illness in people over 50
- People with dementia, admitted to hospital are likely to have a LOS 4 x longer than normal





- Too many people with dementia aren't living as well as they could
- 61% felt anxious or depressed recently
- 40% felt lonely recently.
- 52% don't feel they get enough support from the government.
- 34% don't feel part of their community.
- 28% aren't able to make decisions about how they spend their time.
- 18% aren't living well with dementia.




- There is evidence of the need to improve end of life care*
- There is evidence to suggest that where patients are diagnosed and have a care plan they will have fewer admissions and shorter LOS.
- We have evidence that where diagnosed and have a care plan the carers of people with dementia have less stress and better experiences of care.






The South is the lowest performing region in England






TV highest performing area in the South of England





Within Thames Valley there is a 106% gap in diagnosis rates between the highest and lowest GP practices





- Challenges to improving diagnosis rates:
 - Therapeutic nihilism
 - Conflicting priorities
 - Memory clinic access
 - "mild cognitive impairment"





- 80% of people in care homes have dementia the diagnosis rate there is probably less than the 50% average
- There is no need for referral to a memory clinic and GPs with skills can make the diagnosis. Not all patients require a scan.
- Get it right for dementia and you get it right for other things
 - great opportunity to work closely with social care
- Dementia rarely travels alone 80% have other co morbid long term conditions

- The national priorities for a comprehensive, patient-centred dementia quality improvement programme include the following. The role of the TVSCN in supporting the system to deliver against them is shown in blue.
- Driving up early diagnosis
 - Supporting CCGs to monitor diagnosis, working with local practices
- Developing care planning and service information tools, such as the Dementia Roadmap
 - Choice of tool offered to patients in collaboration with HETV, care planning, end of life master classes and support to develop good EoLC strategies
- Supporting individuals to maintain independence
 - Dementia friendly GP practice pilots and evaluation
- Preventing crisis
 - Crisis concordat, street triage (significant dementia component)
- Providing and sign-posting to post diagnostic support services
 - Baseline map of services, highlighting areas for CCG focus
- Embed consistent standards
 - Event with AHSN on variation in clinical practice
 - Partnership with HETV to drive up Tier 1 and 2 training
