Review and discussion of CIWI Report			
See report previously emailed.			
A couple of areas were highlighted:			
Research Engagement Network			
NHS England funded a number of ICBs to help develop a Research Engagement Network (cohort 1 which was funded at the beginning of the year).			
 The focus of this was to emphasise the fact that we know research is important, we know that research is often not informed by the thoughts and views of local communities and research does not also inform planning. 			

- At the beginning of autumn 2023, NHS England requested a second wave of ICBs be involved in this project and BOB and Frimley were both successful in obtaining funding to develop RENs locally which included the voluntary sector.
- Health Innovation Oxford & Thames Valley are involved with this as well as members of the ICB. Reading Community Action are providing the project management and we have representation from research and local NHS organisations. We are also in the process of appointing a public member to the board.
- Will conduct a comprehensive mapping exercise to map what community work is happening, what works, what training is available, to align engagement work against our population by completing a gap analysis. What do we know about participation – who participates and why?
- Commencing this work with 3 surveys to: 1. VCSE, 2. Local Authority, 3. Researchers/Research Organisations.
- This research population data could be valuable to the Secure Data Environment Project. Jane Hogg is interested in the report/action plan regarding how we embed this work.

- Big projects for CIWI for 2024 Health & Equalities work with BOB, blood finger test for breast cancer markers (Seroxo), AI for breast cancer (IBEX), AI training for doctors to better thrombectomy procedures.
